Min 01/SUS/14/3/2024 REMARKS BY LUCY MBURU

The meeting started at 10.20a.m and ended at 11.45a.m at NAIVAWASCO Water Office in Naivasha with a word of prayers lead by Lucy Mburu followed by self-introduction. The registration of the Tenderers started immediately.

Min 02/SUS/14/3/2024 -BRIEFING AT NAIVAWASCO WATER OFFICE

The team leader went through the tender document and explained the scope of works as follows: -

- 1) Equipping of the borehole
- 2) Rehabilitation of the rising main
- 3) Borehole yield 105m3/hr
- 4) Borehole Depth -28m
- 5) Pumping Water head -300m

It was emphasized that this pre-tender site visit was not mandatory and there is no certificate but the visit was very important as they would carry out the assessment of the works and fill in the tender document without any difficulty.

They were reminded that the crossing date would be 29^{th} March 2024 and if any clarifications. to be addressed to the CEO within 7days before date of closing.

Min 03/SUS/14/3/2024 - DCK BOREHOLE SITE

At the site two number boreholes were found operational and one was found unoperational as the Pump-set and draw off pipes were fished out by Davis and Shirtliff after the borehole failed to operate.

Further, in according to the design, they were explained how the reticulation system will operate. Water is supposed to be pumped from the DCK borehole at Naivasha Water and Sewerage System to $225 \, \mathrm{m}^3$ water tank at the game park and then supplied to the consumers.

Min 04/SUS/14/3/2024 -225M3 MASONRY TANK

The existing tank was constructed at the highest point and its 4kms from the borehole. The tank requires manor rehabilitation and its intended to serve the game park wildlife, the project community people, staff of the Hells gate National Park as phase I of the project.

Min 05/SUS/14/3/2024 -RISING MAIN

The rising main line was found with no marker posts and the bidders were told whoever is awarded would be assisted to locate the pipeline during project implementation.



Min 06/SUS/14/3/2024 - MATTERS ARISING

i) Issue of Construction Materials

Tenderers were informed that the material required for tank rehabilitation would be delivered to site manually by the casuals.

ii) Issue of tender opening date (29th March 2024)

Tenders claimed the date of opening is a public holiday (Good Friday). They were assured they would be notified 7day before the set date.

Min 07/SUS/14/3/2024 -CLOSING MEETING

Tenderers were reminded of the importance of the Pre-tender site visit and told that any issue concerning the tenders that is not clear can be clarified so long as it is requested seven days before the final day of submitting the tenders.

Since there were no other queries the meeting ended at 3.35am with a ward of prayer lead by one of the contractors.


